At Xavier, we have worked as a thriving and successful appropriate body (AB) for over a decade, and currently support more than 800 early career teachers (ECTs) in primary, secondary, SEND, independent and post-16 settings. We are proud to currently work with schools across Surrey, Sussex, Hampshire and Northamptonshire, with more schools joining every year.

Since September 2021, all qualified teachers employed in schools (in England) must satisfactorily complete a two-year statutory induction period, underpinned by the early career framework (ECF).

The role of the AB is to work alongside the early career framework (ECF) training materials, to monitor and support ECTs progress and oversee termly progress reviews and assessments.



Appropriate bodies play a key part in the ECF reforms, schools are free to choose their own appropriate body services, which, as of September 2023, solely delivered by Teaching School Hubs.

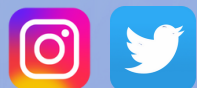
